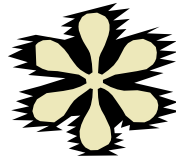

Quarterly Dividends

The Board of Directors voted to pay a dividend of 1.004% annual percentage yield for the quarter ending June 30, 2010 on SHARE savings accounts. The dividend on IRA accounts will be 1.762% APY. The dividend on DRAFT accounts over \$500 will be 0.753% APY. The calculation is based on the daily balance of your account during the quarter. The dividend will be paid on June 30, 2010.

Legal note: Federal regulations prohibit payment of dividends in excess of available earnings. Your savings are insured up to \$250,000 by NCUA, National Credit Union Administration, a US Government Agency.

Remember, we would **never** contact you through email or text message for personal information on your account.
